Caps can vary from pop-up drink tops and drinking tubes for outdoor enthusiasts – to motor oil spouts, and pumps and sprayers for cleaning solutions or personal care products. The appropriate dispenser cap allows ongoing reuse and “Instant Refill” by simply replacing the product bag.

“I believe that corporate leadership with a strong commitment to the environment will be pleased with how this system can differentiate their product from their competition,” says Schroeder. “Cost is reduced because significantly less plastic is used than in bottles, and no new expensive dispensers are required for each refill.
