

Sacramento Area Attorney Earns Bar Certification

EL DORADO HILLS, Calif., July 11, 2012 (SEND2PRESS NEWSWIRE) – The State Bar of California’s Board of Legal Specialization has just certified local attorney Myrllys Stockdale as a legal specialist in family law. Stockdale is one of only seven certified family law specialists in El Dorado County. There are 11 in Placer County, 55 in Sacramento County and none in Amador County. Of California’s 237,000 licensed attorneys, only 1,193 are certified family law specialists – which is roughly 0.5 percent.

From supporting the local chamber of commerce to running for local office, Stockdale is active in her community. She has been named an Outstanding Woman Leader by the National Association of Women Business Owners, Small Business of the Year by the El Dorado Hills Chamber of Commerce and voted Best Law Firm in El Dorado Hills by Village Life Newspapers.
